ISI Sanction: IA-12-17 : Held under the sanction of USA Swimming and Iowa Swimming, Inc.

HOST: Bettendorf-Pleasant Valley Aquatics.

RULES: Current USA Swimming and Iowa Swimming, Inc. (ISI) technical and administrative rules will govern this meet.

DATES: January 6th-7th-8th, 2012.

MEET CLASSIFICATION: Age Group and Senior Open, Iowa 8 and Under Open.

SITE:

Bettendorf High School, 3333 18th Street, Bettendorf, IA 52722(see attached map)
Indoor, 25 yard, 6 lanes. Water Depth: Starting End, 60"; Turning End, 48". International Timing System with touch pads and printout. Secondary back up with one-button system, manual/electronic with two watches on each lane and a 3rd watch on the first place swimmer. Tone start. Hy-Tek Meet Manager software. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

RULES: Current USA and ISI rules will govern this meet.

Coaches Meeting: Friday, January 6th, at 5:20pm; and Saturday, January 7th, at 8:20am.

Reminder that coaches meeting is not held until warm-ups are completed & pool is cleared.

The Meet Management Team may decide to "split" the warm-ups depending on numbers. All clubs will be notified by Sunday, January 1st, by 5:00pm, if sessions are split. **Entering Clubs or Individuals MUST submit an Email Address for their respective coaches in order for visiting clubs to notify their membership. The email listed in the Team Summary Report will be the person notified of any changes to warm-ups & meet updates.**

COACHES:

Must possess and visibly wear a current USA Swimming Coaches Registration Card. Only USA Swimming coach members will be permitted on the deck in designated areas. All coaches must show current coach membership card and sign the ISI coaches meet Sign-In Sheet(APP-29) to verify that all certifications are current and on file. Coach packets will be distributed to coaches after signing in. Only USA Swimming coach members will be permitted on the deck in designated areas.

WARM-UPS:

ISI Warm-up procedure will be followed. See ISI Code Book Section J. All swimmers are to carefully enter the pool using the feet first, three point entry. Athlete members must be under supervision of a USA Swimming member coach during warm-ups, competition and warm-downs. Swimmers without a coach are to report to Meet Director or Meet Referee prior to warm-ups. The Meet Director or Meet Referee may assist the swimmer in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.

RACING START CERTIFICATION:

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ENTRY REQUIREMENTS:

1. All swimmers must be current USA Swimming registered athletes.
2. Contestants must enter the age bracket corresponding to their age as of Friday January 6th, 2012.
3. A swimmer may enter up to **4 (four)** individual events per day, plus **1 (one)** relay event per day.
4. Seed times must be submitted for a 25-yard course.

ENTRY LIMIT: There will be a maximum of 100 splashes per lane per session until the 4-hour rule is reached.

ENTRY FEES:

1. Individual timed final events are **\$3.00** per event.
2. Relay Fees are **\$8.00** per relay.
3. ISI splash fee is **\$3.00** per swimmer.
4. Teams submitting hand entries with more than 5 swimmers must pay a \$2.00 per athlete added surcharge. Payment MUST accompany team hand copy and financial sheet, and must be received by Wednesday, December 28th, 2011.
5. Make entry fee check payable to: **BETTENDORF-PLEASANT VALLEY AQUATICS (BPVA)**.
6. Entry fees are not refundable. Splash fees will be refunded if the entire meet is canceled.

Any team submitting entries electronically will receive the meet results on disk or electronically at the end of the meet. NOTE: Phone & Fax entries cannot be accepted.

ENTRIES:

1. Entries will be accepted from teams in the Iowa LSC & outside LSC clubs entered in 2011 Bettendorf January Splash beginning on Wednesday December 7th, 2011 @ 8:00 AM.
2. Entries will be accepted for all teams beginning on Wednesday December 14th, 2011 @ 8:00 AM.
3. Entries will be confirmed via a return email receipt.

ENTRY DEADLINE:

1. Hand written entries must be received no later than 7:00pm Wednesday, December 28th, 2011. Financial sheet and fees must accompany hand written entries.
2. Electronic entries must be received by noon, on Saturday, December 31st, 2011 with hardcopy, financial sheet and fees due by Wednesday, January 4th, 2012. If fees are not received, the entries will be scratched.
3. Phone/Fax entries and changes will not be accepted.
4. Entries will be accepted in the order received, on a first come first entered basis, until the maximum time line is reached. Entries received after the meet is closed will be returned.
5. BPVA reserves the right to refuse any entries received prior to the opening of the entry acceptance periods listed above.
6. Once entries are accepted; only time updates will be allowed. Any substitutions/additions must be confirmed first with a prior email or phone call to the entries chair prior to the entry deadline.

SCORING: No team or individual scoring (and high points) for this meet.

AWARDS:

Individual ribbons for 1st through 6th place for 12 & Under Age Groups. No awards for Open events.
Heat winner awards will be given to the 12 & under Age Groups only.

MEET COMMITTEE:

A meet committee comprised of the Meet Referee, Meet Director, Coach & Athlete Representative, and one (1) Certified Official acting at large will be established to receive and act upon any administrative protest filed at the meet. The committee will not act upon judgment decisions as those are under the jurisdiction of the Meet Referee. This committee shall act as a review section in the need of an emergency meeting.

MEET OPERATION:

1. Events will be pre-seeded except 500 Free, 400 IM, & 1650 Free, which will be deck seeded.
2. A Clerk of Course held during the Saturday & Sunday, for 8 & under and 10 & under age groups.
3. If names on entry sheets for relays, those names will be on the relays card at the meet.
4. Positive Check in is required for the following events: Senior 400 IM and all 500 Frees (5:00pm on Friday, 1/6); 11-12 Boys 1650 Free (9:00am on Sunday, 1/8); Senior 1650 Free (2:00pm on Sunday, 1/8).
5. If swimmer misses the posted check-in time, and wishes to swim, they'll only be added if there is an open lane.
6. It is not the meet host's responsibility to provide rest for swimmers that enter consecutive events. (i.e. senior and age group events)
7. Host team reserves the right to combine or limit entries to events as needed to best fit the time line constraints. Once the entries for an event have been limited, no swimmers will be added to that event. If any limitations are necessary the affect teams will be notified. There will be refunds for any limited events.
8. The 500 Frees will be swum slowest to fastest, by order of event. The Senior 500 Frees will be swum fastest to slowest, by order of event. The 400 IM's will be swum slowest to fastest, by order of event. The 1650 Free will be swum fastest to slowest, alternating women to men.
9. 1650 Free participants are requested to provide their own timer and counter.
10. Boys 11-12 1650 is limited to 12 fastest times. The Open Senior 1650 Boys and Girls events are limited to the 18 fastest times for each event.
11. BPVA reserves the right to add its own swimmers to fill in heats to the meet, after the meet has been closed.

VENUE RESTRICTIONS:

Bettendorf High School is a smoke-free facility. **NO SMOKING ALLOWED.** USE OF AUDIO OR VISUAL RECORDING DEVICES INCLUDING CELL PHONE, IS NOT PERMITTED IN CHANGING AREAS, REST ROOMS OR LOCKER ROOMS.

USA REGISTRATION:

Late USA-S Registration at the meet is \$60.00 (annual) or \$37.50 (Individual Season - 150 days) payable to ISI and \$5.00 processing fee to BPVA. There will be no Club or Coach registrations accepted.

ADAPTED COMPETITIVE SWIMMERS:

USA Swimming and ISI encourage adapted competitive swimmers to participate in all sanctioned meets. The 'Adapted Competitive Swimmer Information Form' APP-21 must accompany entries. The forms are available from the ISI office. Completion of this information form is part of the entry procedure since the host club and meet referee must have all necessary information concerning the swimmer. 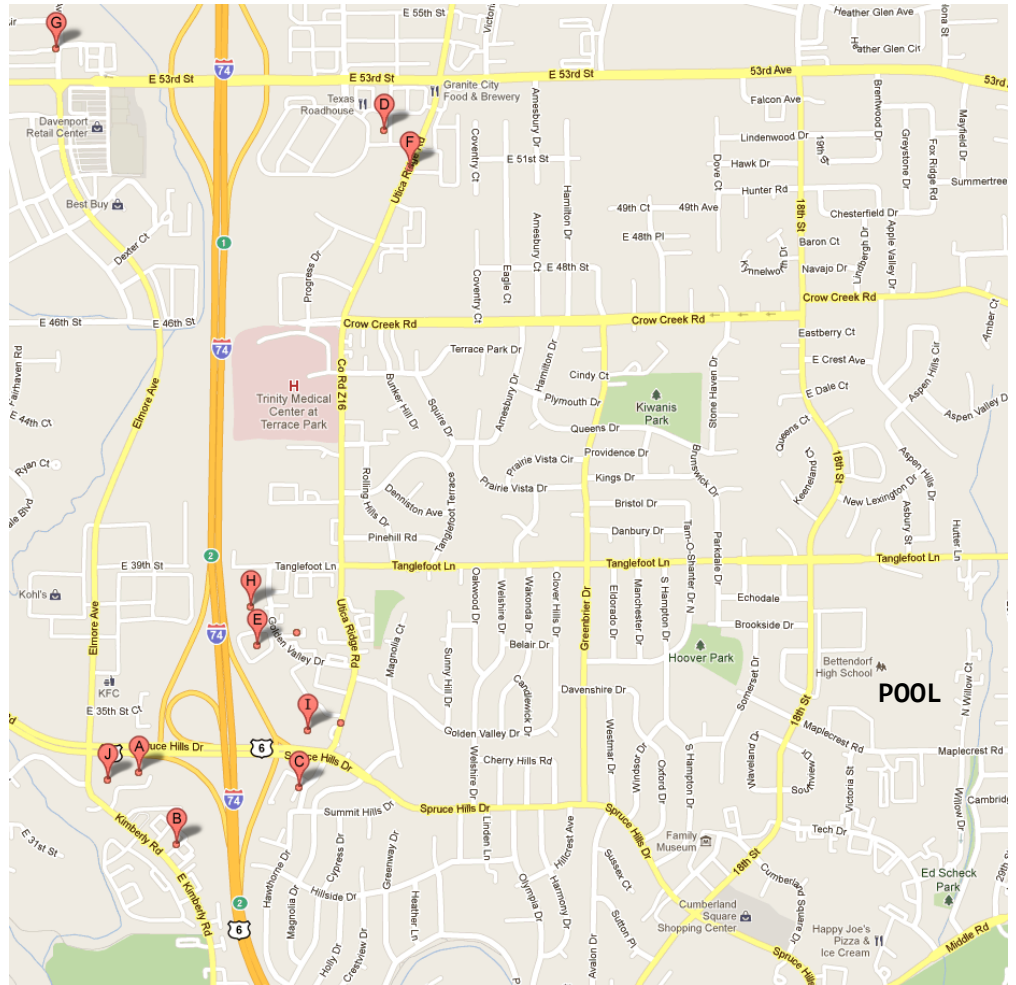
